

#### HELPING ANIMALS IMPACTED BY WILDFIRES

The wildfires have impacted Alberta's animals in many ways, and our staff has been there to help ensure pets and livestock are not in distress.

Alberta SPCA Peace Officers and staff worked hard to help animals impacted by wildfires in Alberta this spring. Team members operated in Drayton Valley and Brazeau County, at the request of the municipalities, feeding animals in their homes; pets that were not able to evacuate with their

families. Teams of Peace Officers, staff members, and locksmiths entered homes with the permission of the animal owners to check on the welfare of the pets and ensure they had food and water to last several days. Peace Officers also helped escort residents into the communities to pick up and remove their pets from the evacuation zone.

#### PROHIBITION ORDER COMES INTO EFFECT

Following her third conviction for allowing animals to be in distress, a lifetime prohibition against owning equines has come into effect for Patricia Moore.

On April 8, 2023, a court imposed prohibition order against owning equines came into effect against Patricia Moore of Parkland County. On year prior, Ms. Moore was convicted on April 8, 2022 on four counts of allowing animals to be in distress. Following the convictions, Ms. Moore filed a notice that she intended to appeal the convictions. The appeal was dismissed by Justice N. Whitling of the Alberta Court of King's Bench in January of 2023, and the prohibition against owning horses took effect this past April. The prohibition order reads; Patricia Lynn Moore shall be on a lifetime ban from owning, caring for or being in possession of any equine animals.

While Ms. Moore's prohibition was originally suppose to come into effect in May of 2022, the imposition of the prohibition was delayed while Ms. Moore sought to appeal her convictions. Once the appeal application was dismissed in January of 2023, the prohibition came into effect in April of this year.

This is the second time Ms. Moore has been subject to a prohibition against owning equines. She was previously convicted of allowing animals to be in distress in 2012 and received a five-year prohibition.

#### **DIANA BOCHAR**

On March 2, 2023, Diana Bochar of Smoky Lake County pleaded guilty in provincial court to one count of allowing an animal to be in distress under the *Animal Protection Act* (APA). In October 2022, the Alberta SPCA received a public complaint of animals in distress at the rural property. Alberta SPCA Peace Officers found more than 40 dogs on the property that presented numerous welfare concerns. Ms. Bochar was subsequently charged with three counts under the APA of allowing an animal to be in distress 2(1), failing to provide medical care to an animal that is sick or wounded 2.1(b), and failing to provide adequate food and water 2.1(a).

As part of her sentence, Ms. Bochar was given a prohibition from owning animals for 15 years. The order states Ms. Bochar shall not own, possess, control, board, breed or live in a residence with any animal including, but not limited to, dogs, cats, ferrets, or birds, with the exception of two pets that must be licensed, spayed or neutered, for a period of 15 years. She must comply with and allow the Alberta SPCA, or their designate, access to such residence to review the living conditions, and conditions of such animals, and the ability for the Alberta SPCA to remove any excess animals or any animal that is not excess but whom the Alberta SPCA deems to be in distress, without warrant.

The animals that received visits included a wide range of species, from cats and dogs, to rabbits and mice, and reptiles such as snakes and geckos. After each visit, the home was secured in the manner it was found before the visit. Pets that were deemed to be in distress or at risk were taken into the care of the Alberta SPCA.

Additional members of the Alberta SPCA team spent considerable time helping transport resources to other parts of Alberta, including delivering food and litter to animals that had been evacuated to the Hinton area. Alberta SPCA Peace Officers received permission to travel past road blocks on the Yellowhead Highway to make the deliveries.

In the far northern part of the province, Peace Officers transported food and supplies to High Level for animals that had been evacuated from a number of communities. With the permission of the owners, our Peace Officers also brought a number of puppies and kittens back to the Edmonton area, animals that had lost their mothers

in the fires and required new homes.

With so many fires in Alberta this spring, and so many evacuation alerts in place, the Alberta SPCA remains ready to help any municipality that requests our assistance and expertise in managing animals during an emergency situation.

#### ALBERTA SPCA LAUNCHES HUMANE EDUCATOR'S TOOLKIT



600 Toolkits were handed out at teachers' conventions this winter

A survey of Alberta teachers conducted in 2020 revealed that teachers see themselves playing an essential role in teaching young people about animal welfare. However, they identified certain barriers to including animal welfare education in the classroom, such as a lack of resources and professional development. In response to the results of the survey the education department created a Humane Educator's Toolkit. This toolkit aims to provide teachers with information and resources to bolster empathy and respect for all living things in the classroom, explain its importance, and remain in alignment with curricular outcomes.

The education department collaborated with different individuals and organizations, including an Indigenous educational consulting firm, Birch Tree Educational Consulting Services and One Health at the University of Calgary, to bring different perspectives and expertise to sections of the toolkit. ...cont'd on page 6.

Our One Family Welfare team is regularly contacted by people looking for help caring for their animals. Our programs, Pet Safekeeping and Crisis Care, are intended to offer temporary care for pets while their owners manage a crisis situation; circumstances such as fleeing domestic violence or the requirement for emergency medical care. Unfortunately, many people who call our department face a difficult or challenging situation, but one that does not meet the requirements for assistance from our organization. This does not mean the pet owner's situation is not dire, we know people are suffering and when people suffer, so do their animals. Our programs are intended to help after all other options have been exhausted as we are a non-profit and have limited funds at our disposal.



So where does this leave the animals that are at risk because their people are in a precarious situation? There are no easy answers but what we do know is that a healthy dose of compassion and kindness is needed from society as a whole. As an organization we understand that often the best place for pets is to remain with their owners. Finding new homes for animals is challenging, and most pets do much better staying with familiar people and surroundings. This means we must find ways to support pet owners so their animals can stay with them.

Alberta SPCA Peace Officers have access to food that they can offer pet owners who just need a little bit of help getting through a difficult time. And our One Family Welfare team is well-versed on the programs available to animal owners in Alberta, whether it be subsidized veterinary care, or affordable housing that allows pets. We do our best to ensure pets can stay with their people, and those people can access services and programs to help care for their animals even during uncertain times. However, everyone can play a part in creating a caring community.




Neighbours and family members can check in with people who might be at risk to ensure everyone, including animals, is alright. And when checking in, Albertans can ensure they're doing so in a compassionate and non-judgmental manner. Few are in an ideal situation these days, so approaching people with concern or an offer to help should come from a place of kindness and compassion.

Of course, there will be those people whose animals are in distress due to their circumstances, whether it be mental illness, domestic violence or economic challenges. Yes, we are tasked with helping the animals first, but we also do our best to ensure animal owners get the help they need as well.


#### Client Spotlight - Melissa's Story

A past client, Melissa (not her real name), was referred to the Pet Safekeeping Program by the Edmonton Police Service's Domestic Abuse High Risk Team after Melissa's abuser was unexpectedly released from prison. Melissa had used the program the previour year when she required care for her two cats while she went into a protective women's shelter. During the second term in our program, Melissa's two cats were with us for only a short period of time, just over two weeks, while Melissa found a new home for her family in a location unknown to her abuser.
